


Figure 1, Wencor Spur Gear Cross Section View




Figure 2, Exploded View of Spur Gear Installation

The Wencor Spur Gear was designed with an ID as shown below in Figure 1, which creates a tight fit onto the ATS Turbine Shaft during installation as shown in Figure 2.

c. Background

The Wencor Spur Gear was designed for an interference fit (.0024 inches max) between the ID of the Spur Gear and the OD of the Turbine Shaft. Due to the small ID on the Wencor Spur Gear and depending upon the OD size of the Turbine Shaft, the installation may require the aid of press tooling or heating of the Spur Gear to fully assembly onto the Turbine Shaft. The component maintenance manual (CMM) does not call out any tooling or heating of the Spur Gear for this assembly process.

The Wencor Spur Gear has been redesigned with a slightly larger ID to create a transition fit, which matches the current design philosophy and allow assembly as described in the CMM.

d. Safety

This condition does not affect aircraft safety.

2. Recommendations

Any Wencor Spur Gear that is currently uninstalled that has the condition described in this SIL may be returned to Wencor for free of charge replacement with the redesigned Spur Gear.

However, any Wencor Spur Gear that is currently installed and in-service that have the condition described in the SIL may remain in service at the discretion of the end user without any change in aircraft safety.

3. Compliance

There is no compliance time frame for this SIL.

4. Material

Wencor Spur Gear's that require replacement as a result of this Service Information Letter will be covered free of charge under the Wencor material warranty.
